NurtureChek Programme Update

After quite a bit of work behind the scenes Global Proficiency is excited to announce that we are further expanding our NurtureChek service scope by offering two new proficiency testing programmes: **Lactoferrin** and **Microbiology**.

Lactoferrin NurtureChek Proficiency Programme

Routine analytical testing of raw material and finished products is an integral part of verification activities for Lactoferrin manufacturing and processing operations. They provide critical information supporting market access, compliance with operator and regulatory requirements, process controls, supplier assurance and process improvement. We are pleased to add Lactoferrin powder and infant formula to the current list of products offered in this programme, as follows.

LAF category: Contains samples of pure lactoferrin with each set containing 2×5 -gram samples. The samples will contain 80 - 95 % lactoferrin. The test offered for this category is 'Lactoferrin Purity (%)'.

LAC category: Contains samples of infant formula that have been dry blended with lactoferrin. With each set contains 2×30 -gram samples. The samples contain 0.5 - 2.0 mg/g of lactoferrin. The test offered for this category is 'Total Lactoferrin (g/100g)'.

Microbiology NurtureChek Proficiency Programme

Regular environmental and product testing for *Salmonella*, *Listeria* and *Cronobacter* species is required for manufacturers of infant formula to ensure an effective risk management programme. The NurtureChek Microbiology Proficiency Programme provides independent verification to laboratories and monitoring agencies, and ultimately to the consumer, that the testing is being carried out competently. We are pleased to expand the NurtureChek Programme to include two microbiology categories, as follows:

MIG Category - General Micro: Sample sets consist of 2 freeze-dried vials, each with an accompanying 70-gm sachet of irradiated infant formula.

MIP Category - Pathogens: Sample sets consist of 4 freeze-dried vials, each with an accompanying 70-gm sachet of irradiated infant formula.

DataChek Case Study

Global Proficiency's DataChek programme has a variety of applications, including supporting laboratories to gain accreditation by providing samples and statistical analysis of results where no other method to ensure validity of results is available.

In a recent case, we provided milk samples blind-spiked with an organic compound and compared the laboratory's results against the expected results, applying their Uncertainty of Measurement to check results were within the expected range. With collaboration from the laboratory to provide guidance on how the matrix and compound would interact, we were able to provide accurately spiked samples which were stable and homogenous for testing.
