# New: Inhibitory Substances in Dairy Powders

We are excited to announce that we are expanding the DairyChek programme in 2025 to include a new category for testing Inhibitory Substances in Dairy Powders. We intend to present this category in two rounds in 2025 – March and September.

This category (code DIB) will be a 4-sample set, testing for Penicillin G (Pos/ Neg). Each sample will consist of a freeze-dried vial and base matrix, and will include the following matrices to begin with:

- Milk Powder
- WPC80
- Lactose

If you are interested in participating in the DIB category, look out for it in the upcoming registrations for 2025.

### BeverageChek - New Cider Round

We are pleased to announce that we plan to introduce a new cider category to our BeverageChek programme.

In response to requests from a recent customer survey, we are planning to run the first cider round in February/March 2025 in place of one of our fruit juice rounds. We will offer one round of fruit juice (apple & orange juice) in September.

The new cider round will be included in the registration information pack due to be emailed to participants mid-October 2024, so keep

an eye out for the new Programme Description containing additional details.



# TimberChek Pricing Update for 2025

The Timber Proficiency Programme is designed for laboratories routinely testing timber treated with preservatives. The programme offers a range of tests to participants, including the major preservative groups used by the timber industry in the treatment of timber products.

Participation in this programme has previously been charged on an annual-participation basis. From next year, the pricing structure will be aligned with Global Proficiency's other programmes, with participation being priced on a per-category basis.
