VeriTest[®] Probiotics Proficiency Programme

Did you know that in March 2024, Global Proficiency offered our first VeriTest[®] Probiotics round? We provided 4 samples of dairy-based powders containing *Bifidobacterium* or *Lactobacillus* species at a 'final product' level.

Depending on the level of participation, we plan to further develop the programme to include probiotics at high levels representative of 'raw material' alongside samples at low levels appropriate for carry-over testing. In addition, we will look at including other microorganisms commonly used in probiotics. Although we had reasonable participation in the March round, a decrease in the subsequent round means we need to review whether we can offer probiotics in 2025.

If your laboratory undertakes testing of probiotics and you haven't registered as yet, then we would encourage you to consider participation in this programme. You can

benchmark your performance among a network of other laboratories, and your feedback is extremely valuable in helping to develop this programme further.

Steph is currently studying for a Bachelor of Commerce at Deakin University hoping to become an Accountant.


In her spare time she likes to take dance classes as she is also a professional dancer! She also enjoys watching movies and going out with her partner to try different cuisines.
