DataChek— UoM

Global Proficiency's DataChek Uncertainty of Measurement (UoM) service is offered as a way to easily and efficiently estimate your laboratory's measurement uncertainty. Regularly providing data to a proficiency provider builds up a catalogue of information that can be very valuable.

Assuming you have participated regularly, we offer three reports to help you estimate your UoM. The first report is simply a file containing your raw historical data which you can upload into your own system, or manipulate in a spreadsheet. The second report is a statistical analysis of each test method and the associated UoM, Bias, and Total Analytical Error (TAE). The third report plots past Z Scores onto a Levey-Jennings chart and applies a number of Quality Control rules collated and adapted over many years (Westgard Rules).

Your laboratory UoM's can then be monitored in future ILCP rounds by submitting them alongside your results where they will be assessed in a ILCP round UoM report (which is part of our current suite of ILCP reports and is at no additional cost).
